

# Register for PREA Certification Training – Learn to Deliver PREA-Preventing Sexual Misconduct Against Offenders Workshops


The standards adopted by the Department of Justice (DOJ) relating to the Prison Rape Elimination Act (PREA) will require criminal justice agencies to provide extensive training to staff, volunteers, and auxiliary personnel for all criminal justice agencies housing juveniles and adult offenders, including adult and juvenile probation residential facilities, parole and community corrections facilities, lockups, jails, and prisons. Additionally, the new standards will require agencies to adopt policies regarding zero tolerance, incident investigations, appropriate screening, and more.

NCTI's PREA-Preventing Sexual Misconduct Against Offenders Facilitator Certification Training addresses the staff training standards adopted by the Department of Justice, and provides agencies with prevention and identification strategies to reduce incidences of staff sexual misconduct.


This certification training is a fast-paced, interactive course that teaches criminal justice professionals how to effectively facilitate one of NCTI's 8-hour Preventing Sexual Misconduct Against Offenders curricula. The training uses reality-based scenarios, activities, role plays, and group interaction to provide the necessary tools to effectively recognize and substantially reduce staff and offender victimization. This training addresses the importance of individual learning styles and behavior. Practice sessions allow participants to become familiar with the NCTI Preventing Sexual Misconduct Against Offenders curriculum.







- Identifying and avoiding inappropriate use of power and consent of staff against offenders
- Understanding and using screening criteria to identify characteristics of perpetrators and victims
- Identifying policy and procedure changes necessary to comply with the PREA standards
- Applying communication techniques with LGBTIQ populations
- Exploring gender issues within the criminal justice system


